Amber: if anybody who has not copy of draft budget and want a copy they are up front (passes them out), pretty much same as last month. One thing we did not foresee which is that if we have money to do so we send 2 people. to Boise in March for. Tried to make budget larger but seems small to me. Because we had that amount were

going to run a deficit budget. We had increase with regards to PRAASA was \$1600. Underneath that is reimbursement for DCM's right now \$1350. We had it at \$1800-\$1850. We've had an unprecedented # to make themselves available. What is the figure to the right that has all this info you can see, but there is a line "to be revaluated in June." We will keep an eye on it and check in June.

GSR: Why were items added for income for conferences and events and individual conferences and events added?

Amber: not unprecedented. We don't; know if we will get individual. Contributions. No pressure for people. To contribute but some might.

Teddy: Any objections?

Budget passes.

Presentation of Concept 1: Seems we did not have a volunteer.
 Teddy asks for a volunteer. Paddee Volunteer (shamrocks and serenity)

Paddy (reads concept short version) – authority resides with groups not w/ authorities. Bill traces how this upside down structure came to be. 1938 Alcoholic foundation 1954 renamed to service board. Lit, pub info, new groups get started; experience of getting group started etc. stuff AA groups couldn't do alone. Both board an office looked to cofounders for policy and leadership. Great res. From trustees, AA called GS conference. Groups themselves and AA members are in control not a founder or trustees.

• Visiting Officer/Former Delegate Presentations:

What GSRs need to know at the start of the panel | Agustin XX, CNCA Treasurer, Panel 63: How we do business in CNCA.

Agustin: we don't rush to take decisions as you know. When a new motion comes to an agenda, the chair presents it as new business. Then we have opportunity to ask as many questions as you can about the motion "why," "how we got to this motion ", what's its intent?" Also the chair affects this process. At the area meeting you will met trusted servants in the area. After the discussions and opinions it becomes "old business" If you are still not ready to vote but not clear what exactly what the motion is about you can still decide to discuss the motion as long as you want. It is your decision. And then when you get ready to vote you can just vote it. Our 4th warrantee says every decision we take in AA should be discussed, voted and as much unanimity as possible b/c we don't just want a majority that imposes its will or decision. We want everyone to be agreed or happy with the decision we are going to take. But, We don't take decision about what will make people happy, but what is best for AA. That's why we discuss and talk and talk until we get clear what is the decision we are going to make. At the begging like I said, we don't rush. That's about all the GSR, DCM< DCMC in district an area officers and area and all that an committee meetings will decide motions. Thanks for letting me serve and if you have nay questions please ask me and I will be happy to serve.

Amber: I have a question what's housekeeping vs. regular motion

Agustin: good question! Yeah you see Teddy presenting housekeeping motion. The difference is housekeeping can throw out in a meeting, and if there is no objection it is just passed. In the other case it's a motion is presented as new business and it has to be discussed then it becomes old business then it is decided. Housekeeping can be done and decided in a meeting.

Teddy presents Doug G

Doug GXX, Past CNCA Delegate, Panel 53: What GSR's need to know at start of a panel: 2003 and 20-0-4 panel 53 delegate. 1995 new GSR went to SJ for first meeting in district 40 was GSR for deaf group I didn't' know what to do but was nosy and curious. Went to an assembly and was amazed to se business of AA going on and enthusiastic. I was hooked to see love and service for no \$ and I was hooked. What does a GSR need to know? I sat in on orientation and was great by Andy. I want to welcome new GSR tonight. So you go to 1st AA meeting and they speak English but don't' get it. If you feel that way you're in the right place. You will learn and then in 2 years it will be time to rotate. When we translated we are not professionals into Japanese: we are always amateurs. So always be an amateur. Yes we have a board of directors, 93 delegates etc. and make decisions, but if conference doesn't know how groups feel about things they make a decisions in a vacuum. Then your job is to get group conscience to share and then take to NY so they know what they are deciding on. Paddee wants to know how your groups feel about what is going on in AA. You are that crucial link between your groups and with the board who do the day to bay business. As Augustin mentioned, you will be subjected over time to General Service. Items. You will want to take them to groups, area business or assembly business and you want to take business items to your group conscience and then later district meeting and you bring back result to group. It's a 2-way street that we facilitate. You will then hear stuff from say Vacaville form Paddee about what happened in NY and you take that back to your group. So they know what is going on in AA as a whole. We talk and we talk because we need to get a voice through informed group conscience to determine what God wants us to do to be of service ice to drunks and be of max service to them. We also have minority opinion to keep us in check. We have a calendar. Write down assembly and other important dates we have 4 district assemblies write those down. We have assembly in Boise: PRAASA in March if you can go in March. GO! 15 areas are coming together in Boise and will talk about the same things so you can educate yourself another more Also have unity days conference etc. So keep a calendar so you know what is going on. I missed a meeting assembly meeting that is and my sponsor called me out about it. Get help form other GSR's with experience to learn Get a service sponsor.

Read a lot read everything you get because all will help you understand what is going on. It won't make sense at first but it will make sense. There is a whole chapter in the service manual for GSR so read lots because you will learn your role. Also get an alternate so you can have someone rotate in when you rotate out. I want to leave you with spiritual nature of what we do. Trying to find out through informed group conscience what God wants us to do to be of service and of maximum service to drunks out there Board doesn't' dictate how AA will run to groups it's the reverse. Because groups are on the front line. We need tools and services to do that GS allows us to do that and gives us tools. If we needed to change pamphlets etc. we can bring it to GSR and we can Change it if it doesn't work anymore. Bring it do district and talk about it in a business meeting and if district agrees goes to area and if area agrees goes to NY. They need to know what we need on front lines here and your job is to make info flow 2 ways bring from groups and share back to groups. I had to get a group conscience even though my group refused, by taking them to coffee at Denny's We have to do this to ensure that others get it later on.

4th vote: Susan gets it with 39 votes.
