General Service Ad Hoc Committee – 2019 Meeting Space Report: Justin H. Alt DCMC

The Ad Hoc committee has been diligently researching potentially new meeting spaces for the 2019 Calendar Year. As most of you may know, our current rental arrangement here at St. Mark's is ending at the end of this year and we have been tasked with finding a new meeting location. I would like to begin by thanking those members of the Ad Hoc committee for their efforts as well as the numerous members of this committee and AA in general for offering their input and opinions. As of today, we have located three (3) potential spaces that meet our budget requirements. Many other locations were investigated but were either prohibitively expensive or we were unable to receive a call back or return message from the building management. The three viable locations currently before the Committee are as follows:

- 1. Old First Church located at 1751 Sacramento Street, SF, CA 94109
- The rent would be \$150 per use
- The manager Brad is very open to our group and extremely supportive
- Use of the main room, tables, chairs, projector screen and will have space to leave coffee pots
- Our responsibility: set up, break down; disposing of garbage, recycling, and compost in designated bins
- We will have a key to enter the building
- Men's and Women's bathrooms
- Overall this space is very attractive as it is close proximity to Central Office and previous meeting space
- Brad has already reserved the second Tuesday evening from 6-9pm through 2019 for us just in case
- The one downside would be a lack of separate parking, street parking only
- 2. St. Cyprian's located at 2097 Turk Street, SF, CA 94115
- The rent would be \$200 per use
- Vicar Tom is very friendly and welcoming
- Key pad at entry door
- Space is large enough to accommodate 75-80 people easily
- There are chairs and tables for use; we are responsible for set up and break down
- There are 2 unisex bathrooms
- Fully functioning kitchen; leave coffee maker there or ask to use another AA meeting's coffee maker
- We are responsible for properly disposing of trash and recycling in marked containers
- The church takes up an entire block and street parking appears available
- 3. St. John's located at 25 Lake Street, SF, CA 94118
- Rent would be \$150 per use
- We would have a key
- One unisex bathroom
- The Second Tuesday of the month is NOT available
- The only days in 2019 that are available during 6-9pm are Fridays
- Check calendar on website for availability

- We would have tables and chairs and either set up in the fireside room (approximately 50 people) or the Sanctuary (much larger)

- We would be responsible for setting up and breaking down
- There is a little challenge with the church management regarding coffee at the moment
- We would be welcome in this space

Other spaces that were contacted:

- 1. St. Mary's multiple phone calls with no response
- 2. Unitarian Universalist Church contacted but rental price was prohibitive
- 3. Marin Preparatory School contacted but no response
- 4. St. Philip's any report?
- 5. Potrero Hill Neighborhood House Researched but rental price was prohibitive
- 6. St. Mark's Prohibitively expensive
- 7. Urban Life Center Timing prohibitive
