Presentation from Jeff O., member — Motion process: started in GS a long time ago; observed area chair & district chair early on; took notes; prepared a document; AA not governed by rules; rem re Rule 62; chair shouldn't provide answers, answer q's, voice opinions; important to be familiar w/Robert's Rules of Order (good for aggressive people) — best to know when NOT to use them; more important to know Service Manual; AA gives all right to participate; leader largely a timekeeper role; no one allowed to speak 2x until all have had a chance to speak 1x; use common sense; chair "no smarter than anyone else"; chair has no moral authority over others; small "t" traditions — Traditions, Concepts, Steps, Charter; this is about spiritual principles rather than rules or rigidity; hear the motion — 2<sup>nd</sup> or group conscience; ask for clarification & q's about intent of motion; don't ask for loving discussion yet; housekeeping motion to handle minor matters — these are usually not expensive, routine, not affecting AA as a whole; go from presentation of new business for next month — get group consciences, give at next meetings; pause; try to bring out minority opinion; "we are informed, not instructed"; exceptions to going slow if urgent; can go to old business — then vote; ok for chair to say — let's vote next time, even if most people seem ready to vote; "tyranny of the majority" — use simple majority or

substantial unanimity (2/3); count votes, then ask for min opinion; ask for any changes in majority if they want to motion to reconsider; CNCA more interested in right of participation.
