Election for Bridging the Gap Co-Chair

"Bridging The Gap helps alcoholics on the inside get to meetings on the outside."

- Orientation is 1st Tuesday of the month at 6:30pm, BTG meeting follows at 7pm
- Co-Chair would serve a 2 year commitment (job description was flashed on screen and was included in meeting materials)
- Rudy S. M. raised his hand to indicate that he was available to serve. He had previously served on the Bridging the Gap committee for San Mateo county. No one else raised their hand so we held a vote of confidence.
- There were no objections so Rudy was elected as the new BtG co-chair!

Housekeeping Motion

"That the District contribute \$2500 to the General Service Board of A.A."

- We are presenting this as a housekeeping motion as the district has excess funds above our prudent reserve and could therefore send as a one-time distribution to help GSO get closer to their target prudent reserve amount.
- There were no questions on wording or intent, so Jackie then presented as a motion for us to vote on. There were no objections so the motion passed and Riaz will write a check to GSO.

New Business

- "That the District Committee Meeting on the 2nd Tuesday of each month permanently remain on a virtual platform. Other District special events, such as the Agenda Topics Workshop, Delegate's Report and Unity Day, may be held in person with remote access whenever possible."
- Rudy S. M. asked if there was any data around headcount for virtual versus in-person for our district meeting. Jackie clarified that there isn't anything, but it does seem
- Heidi H. shared that she thinks this would be a good idea -- it's good for the environment, it's good for those who don't like to drive at night, and the meetings seem to go smoothly in this format.
- Kim S. wondered if that would mean anyone who serves as DCMC going forward would have to have internet access and computer/laptop access.
 Jackie said there may be a possibility that the DCMC could use the Central Office laptop if that is a need.
- Anna V. is generally in support of staying virtual as it has seemed to bring a
 wider variety of attendees. She also wanted to point out that having the
 meetings virtual reduces the # of paper handouts -- having everything
 readily available on the Google drive helps for organization and focus.
- Julie S. really liked the question about accessibility (internet and computer access) and was wondering if GSRs might want to meet up IRL to share a screen.
- Joe W. shared that it would probably be easier to recruit new GSRs if we stay virtual.
- Alison T. shared that she has several health issues that makes the virtual meetings preferable for accessibility reasons. She did also share though that her new sponsees who have only known Zoom meetings don't quite understand the "magic" of in-person meetings.
- We will continue discussing this business next month

<u>Visiting Area Officer: Eric L. (Area Alt Delegate)</u>

- What is happening in 2022? Hopefully things get better than the past 2 years!:)
 - There will likely be discussion at the General Service Conference in 2022 around some of the big changes that were made at the 2021 conference. The final agenda topics are still being landed, but there will likely be some more "exciting" ones!
 - O Is there anything a GSR can do to prepare for when they need to bring agenda topics to their group? Use the time in December and January to get a group conscience on the old business being discussed at the pre-conference assembly! This will help you get a feel for asking for a group conscience on a topic.
 - O PRAASA happens once a year in different locations along the west coast and Hawaii. The 2022 conference was supposed to happen in Portland, but because of different state mandates still happening around Covid, it will be virtual. This will be held March 4-6, 2022.
 - O Pre-conference assembly will be in Petaluma on April 2-3, 2022. This will be in person for the first time in a couple of years! You can also send your thoughts to Eric or Jennifer by April 9th to ensure it is captured before the General Service Conference.
 - September 16, 2022 will be the Regional Forum conference in Salt Lake City.

2022 Budget

- Riaz did a screen share of the proposed 2022 District 6 budget and walked through some of the highlighted changes (i.e. Grapevine is already paid through next year, virtual PRAASA, etc.)
- He did also mention that regardless of whether our monthly meeting stays virtual or meets in person, we need to have money in the budget for rent now in case.
- Rudy brought up if we would need to have another vote on the 2022 budget once we decide if the meeting is staying virtual. Riaz clarified that we wouldn't bring the whole budget to another vote, we would have another ad hoc finance committee discuss what to do with the excess funds.

- We are voting on the budget as a housekeeping motion since we need to vote on this today. There were no objections to the proposed budget so it is approved!
- The ad hoc finance committee will now be looking at how we can improve financial reporting

 - O They meet on the 2nd Sunday of every month, but the meeting time has changed! It is now at 1pm.
 - O Had a gingerbread house making event last weekend
 - O Thanks to folks spreading the word of GGYPAA as attendance is up!
 - O More events coming up soon...
- Kyle W. made an announcement for the Sobriety By The Bay conference happening January 7-9, 2022 at Grace Cathedral. Before January 1st, the
