- Riaz shared his screen which showed 2022 projected costs, 2022 actualized costs to date, and 2023 projected costs for different categories.
- Jackie noted that some tweaking may be done at the ad-hoc level so we do not have a deficit for the 2023 proposed budget (i.e. perhaps removing interpretation costs).
- Dennis H. asked what the 3 hybrid events would be Jackie said it would be Agenda Topics Workshop, Delegates Report, and Unity Day, but not necessary to be in-person.
- Alison T. asked if this budget takes into account the events/categories that involve Intergroup participation as they are strapped for cash right now. Riaz stated that in the spirit of singleness of purpose, the committee only considered what the District would be financially responsible for.
- Beth S. asked for clarification on how the scholarship for PRAASA is listed for 2022 (when she attended) and how it is listed for 2023. Riaz will address.
